On 2/12/17 at 0243hrs, I (Officer Burke) was on foot patrol in the South Side Flats when I was dispatched to the intersection of E Carson St and S 23rd St for an assault where two males were knocked unconscious.

When I arrived on scene, I spoke with victims Dallas Cousins, Zachariah Jarvis, and Nathan Watt who stated that a male named Darrelle REVIS had assaulted them. I first spoke with Cousins who stated that he was walking eastbound on E Carson St when he noticed a male standing at the intersection of S 23rd and E Carson St that looked like the NFL player Darrelle REVIS. Cousins described the male as a black male with a black ball cap, black zip up jacket, and dark colored jeans. Cousins stated that he asked the male if he was in fact Darrelle REVIS and he confirmed that he was. Cousins stated that he was in disbelief stating "No you're not" and the male stated that he was in fact Darrelle REVIS. Cousins stated that REVIS began becoming irate and began waving his hands in his face telling him to get out of his face. Cousins stated that REVIS pushed him in the chest and told him to get out of his face and that is when Cousins started recording video on his cell phone. Cousin stated that REVIS began walking away from him headed eastbound on E Carson St while he was recording him. Cousin stated that he wanted to get what REVIS was wearing and his actions on video. Cousin stated that once REVIS saw that he was recording him, REVIS pulled the phone from his hand and attempted to delete the video. Cousin stated that he attempted to get his phone back from REVIS by pulling it out of his hand but was unsuccessful and REVIS threw his phone in the middle of E Carson St attempting to break it. Cousins stated that another black male showed up on scene as he and REVIS were arguing over him throwing his phone and Cousin stated that he believed that he was REVIS' friend. Cousin stated after arguing over his phone, the next thing he remembers was getting punched and then waking up to talk to police.

I then spoke to Zachariah Jarvis who confirmed Cousins' story and said that he too was attempting to grab Cousins' phone off of REVIS before he threw it into the street. Jarvis stated that after REVIS threw the phone into the street, he too was punched and remembers waking to speak to police.

I then spoke to Nathan Watt who confirmed Cousins' and Jarvis' story and stated that after Cousins and Davis got punched unconscious, REVIS approached him and stated "I got more guys coming". Watt stated that REVIS stepped within a foot of his face with an aggressive demeanor on his face, fists clenched and stated "Do you want to be next". Watt stated that REVIS and the unknown black male then fled the area heading westbound on E Carson St. Watt stated that he then attempted to wake Cousins and Jarvis as they were still knocked out. Watt described the unknown male as a black male around 5'11" wearing a black tee shirt and had a tattoo of stars on his neck. I asked Watt if it was REVIS or the unknown male who knocked out Cousins and Jarvis and he stated "I don't know, it happened so fast". I asked Watt how long Cousins and Jarvis were unconscious and he stated "At least ten minutes".

NOTE: While on foot patrol earlier in the night around 0030 hrs, I had seen Darrelle REVIS standing in front of The Flats on Carson (1500 E Carson St) and noticed that he was wearing a black ball cap, black jacket with a white globe and white lettering on the back, and jeans.

After interviewing all three victims, I asked Cousins if I could see any video footage of the incident. The video was captured at 0229hrs and after reviewing the video Cousins captured, the video showed a black male wearing a black ball cap, black jacket with a white globe and white lettering on the back, and jeans becoming hostile towards Cousins and his friends. The video then shows REVIS walking away from the group and Cousins following him describing what REVIS is wearing. The video then shows REVIS standing in front of White Eagle bar (2300 E Carson St) and stating "Why are you following me" several times before the video stops.

After viewing what the male was wearing in the video and what I saw REVIS wearing when I saw him earlier standing in front of The Flats on Carson, I confirmed that the male in the video was Darrelle REVIS.

After speaking with Cousins and Jarvis, Watt had walked into the intersection and retrieved Cousins broken phone case from the middle of 23rd and E Carson.

I observed injuries on both Cousins and Jarvis, Cousins having a contusion above his left eyebrow the size of a half a golf ball with a one inch laceration on it and Jarvis having a contusion on his right cheek. Both Cousins and Jarvis refused medical treatment and were released to catch a taxi home.

On 2/12/17 at 1600 hrs, I spoke with Cousins to see if he was available to come to Zone 3 Station for an interview and he stated that Jarvis was his roommate and that he and Jarvis would come to the station. When the two arrived at the Zone 3 Station both Jarvis and Cousins informed me that they had sought out medical treatment once they went home to their apartment. While at Heritage Valley Sewickley Hospital, Cousins was diagnosed with a orbital floor fracture and Jarvis was diagnosed with a contusion on his cheek.

First I spoke with Cousins who gave the same story that I received at the time of the incident but listed more friends of his that were there.

Cousins stated that in addition to Jarvis and Watt, his friends Kenneth Ward, Ross Bryne, and Ryan Bukovich were present during parts of the altercations. Cousins also informed me that after telling a friend what happened last night, the friend had sent him a screen shot of a picture on a friend's Instagram of REVIS in the South Side last night wearing the outfit that Cousins had described. I have since viewed and saved the image for court.

I then spoke to Jarvis who again stated that he could not remember anything further because he was knocked out.

I made photo copies of both Cousins' and Jarvis' medical discharge papers, had Cousins send the video he captured on his phone to my email and released them both.

At the time of the incident, three calls were placed to 911 one of them being Cousins.

I followed up with one of the callers, Tim Harman, who stated that he was a cab driver that saw an argument ensuing at the intersection of S 23rd and E Carson St and saw two males unconscious on the ground. Harman stated that he pulled over on S 23rd St and watched to see if the two down males were going to get up and when they did not after five minutes, he then called police. Harman stated that the two black males that were involved in the argument began fleeing the scene once the fire truck had arrived.

I followed up with another caller, Lisa, who stated that she lived above the White Eagle and saw the two males unconscious and when they did not move after five minutes, she called police.


