<b>Statutory Language</b>	the defendant, with intent to cause the death of another person, attempted to cause the death of such person; the defendant, with intent to cause serious physical injury to another person, attempted to cause such injury to another person by means of a dangerous instrument ; the defendant, with intent to cause physical injury to another person, caused such injury to another person by means of a dangerous instrument ; the defendant, being at least eighteen years old, and with intent to cause physical injury to a person less than seven years old, caused such injury to such person; the defendant knowingly acted in a manner likely to be injurious to the physical, mental, and moral welfare of a child less than seventeen years old; the defendant knowingly and unlawfully possessed a controlled substance;
<b>Complaint Language</b>	I am informed by an individual, hereinafter referred to as "individual 1," of an address known to the District Attorney's Office, that the defendant cut individual 1 on her upper lip area with a sharp, metal object. I am further informed by individual 1 that the defendant cut a second individual, hereinafter referred to as "individual 2," and a child, with the aforementioned sharp, metal object at the abovementioned date, time, and location. I am further informed by individual 1 that the child's date of birth is ___/2020, and that the child is

one-year old.

I observed a bleeding laceration on the upper lip area of individual 1, a bleeding laceration on the forehead of individual 2, and a bleeding puncture wound on the chin of the child.

I am informed by Police Officer Panton of the 1st Precinct that he recovered a marijuana-like substance from the defendant. I am further informed by Police Officer Solomon that, based upon his professional training as a police officer in the identification of drugs, he believed the substance to be either marijuana or synthetic cannabinoids. I am further informed by Police Officer Solomon that the substance field-tested negative as marijuana, and that the defendant stated, in substance, "It's K2."
